- a. Piper Point: energy usage, new motor for pump: **Dramatic increase in energy use, currently being evaluated by board members. Possible cause could be the new pumps (running more often), leaks during the recording period and or both valves open until all repairs made. Board will monitor and have JJ Pump make sure pumps are set correctly and wait for future PG&E bills.**
- b. Markers for lateral valves: **On hold for the time being.**
- c. New lateral valves: #54 Ch **On hold for the time being.**
